District & School Profile

The Southern Kern Unified School District is comprised of two elementary schools, a middle school, a high school, an independent study school, and a continuation high school.

Abraham Lincoln Independent Study is a K-12 alternative to traditional and continuation schools that provides educational services for students who are experiencing difficulty participating in the traditional school setting and/or who want more individualized and self-regulated instruction. When a student chooses independent study, the student takes on more responsibility, needs to be self-directed and disciplined to complete all assignments and attend regular meetings with teachers. Parents need to make the commitment to become more involved than they may have found necessary in the traditional setting.

Abraham Lincoln's High School students graduation requirements, of 230 credits, are the same as those of the comprehensive high school.

During the 2020-2021 school year, 133 students were enrolled in grades K through 12.

2022-23 Quality, Currency, Availability of Textbooks and Other Instructional Materials

Southern Kern Unified School District held a public hearing on September 21, 2022, and determined that each school within the district had sufficient and good quality textbooks, instructional materials, or science lab equipment pursuant to the settlement of Williams vs. the State of California. All students, including English learners, are given their own individual standards-aligned textbooks or instructional materials, or both, in core subjects for use in the classroom and to take home. Textbooks and supplementary materials are adopted according to a cycle developed by the California Department of Education, making the textbooks used in the school the most current available. Materials approved for use by the state are reviewed by all teachers and a recommendation is made to the School Board by a selection committee composed of teachers and administrators.

Statewide Assessments

Where the most viable option, LEAs were required to administer the statewide summative assessment in ELA and mathematics. Where a statewide summative assessment was not the most viable option for the LEA (or for one or more grade-level[s] within the LEA) due to the pandemic, LEAs were allowed to report results from a different assessment that met the criteria established by the State Board of Education (SBE) on March 16, 2021. The assessments were required to be:

- Aligned with CA CCSS for ELA and mathematics;
