All licensed contractors are invited to submit the name of their firm to the District for inclusion in the District's list of qualified bidders for Year 2016-2017.

- The name, complete address, including zip code to which a Notice to Contractors can be mailed.
- The telephone, fax number and email address at which the Contractor may be reached.
- The class of the Contractor's License(s) held, Contractor License Number(s) and Contractor License expiration date.
- The type(s) of work in which the Contractor is interested and **currently licensed** to perform, such as Class A – General Engineering, Class B – General Building, Class C – Limited.

This announcement is sent to various trade journals for publication as a requirement of the CUPCCAA to establish and maintain a list of qualified contractors per the applicable sections of the Public Contract Code. CONTRACTOR REGISTRATION

California Uniform Public Construction Cost Accounting Act

The Southern Kern Unified School District (District) has elected to become subject to participate in the California Uniform Public Construction Cost Accounting Act (CUPCCAA). The District is inviting all contractors to submit information for inclusion on the District's list of qualified bidders for the 2016-2017 year.

What is CUPCCAA?

The California Uniform Public Construction Cost Accounting Commission is under the umbrella of the California Uniform Public Construction Cost Accounting Act (CUPCCAA) and provides for alternative bidding procedures when an agency performs public project work by contract.

- Public projects of \$45,000 or less may be performed by negotiated contract or by purchase order (PCC22032 a).
- Public projects of \$175,000 or less may be let to contract by the informal bidding procedures (PCC22032 b).
- Public projects of more than \$175,000 shall be let to contract by formal bidding procedures (PCC22032 c).

In November of each year, participating districts place an ad in various construction trade journals inviting all licensed contractors to submit the name of their firm to the district for inclusion on the district's list of qualified bidders for the following year.

Southern Kern Unified School District has completed all the necessary requirements to participate in this alternative bidding process and solicits your firm to register.

CONTRACTOR REGISTRATION FORM

California Uniform Public Construction Cost Accounting Act

Under the guidelines of the California Uniform Public Construction Cost Accounting Act (CUPCCAA) defined in Public Contract Code Section 22 ---et seq., the District seeks trade professionals and contractors to register with the District for work on the following areas:

- Class A – General Engineering Contractors
- Class B – General Building contractors
- Class C – Specialty Contractors including, but not limited to: insulation and acoustical; boiler and hot water heating; framing and rough carpentry; cabinet, millwork and finish carpentry; low voltage systems; concrete; electrical; elevator; earthwork and paving; fencing; flooring fire protection; glazing; HVAC; building moving/demolition; ornamental metal; landscaping; lock and security equipment; painting; plumbing; refrigeration; roofing.
- Class C – Limited specialty classifications, including but not limited to: elevated floors; synthetic products; hardware, locks and safes; machinery and pumps; doors, gates and activating devices; paperhanging; pole installation and maintenance; prefabricated equipment; pool and spa maintenance; tree service; window coverings; hydro-seed spraying; construction cleanup etc.
- Vehicle maintenance and repair
- Communication systems including telephone and data
